
In the coming year, our focus will be on continuing to strengthen our core of staff, seek out administrative efficiencies, explore alternative funding and practice good financial stewardship.



This last year has been a year of positive change here at Rogers Childcare Centre. We have successfully expanded enrollment in both our before and after school programs!
